(5) Out of the applications recommended by the University, the State Government may grant permission to such institutions as it may consider right and proper in its absolute discretion, taking into account the State Government's budgetary resources, the suitability of the management's seeking permission to open new institutions and the State level priorities with regard to location of institutions of higher learning.

Provided, however, that in exceptional cases and for the reasons to be recorded in writing any application not recommended by the university may be approved by the State Government for starting a new college or institution of higher learning.

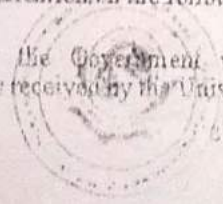

2. If no reply has been received from the Government on or before 15<sup>th</sup> July, 2009, it will be presumed that the permission has not been granted by the Government for opening of your proposed new college for the academic year 2009-10.
3. If the permission is received from the Government after 15/7/2008, the said permission will be considered for the subsequent year i.e. 2010-11 for opening of your proposed new college, as per the Maharashtra Universities Act, 2000.
4. 
